INFORMATIVE NOTES (English)

These products are rated as **Personal Protection Equipment(P.P.E)** and are suited of snow sports and motorcyclists. They are designed and manufactured to provide limited protection against shocks and injuries that might occur in the protected body regions as a result of a fall.

TYPES:PAE(XL/L/M/S/JL/JM/JS) CE MARK

The CE mark applied to each PPE proves that the manufacturer has complied with all the requirements for this type of product prescribed by the EU directives and standards controlling the issue and application of the mark.

Specifically, the PPE's conform to the European Directive 89/686/EEC Annex II, the General Requirements EN 340/93 and the relevant European Technical Standards EN 1621-1/97 and EN1621-2/03 and specific tests for the shock absorption at low temperatures. Conformity with these requirements has been certified by Notified Body n. 0498-Ricotest S.r.i., Via Einaudi,6/8,1-37010 Sandrà(VR).

RISKS / PROTECTIVE LEVELS

The protectors are designed and manufactured to provide limited protection against injuries that might occur on falls or collisions. This protection is ensured only when the P.P.E.'s are correctly fastened. Back protectors do not prevent spinal injuries.

IMPORTANT: These protectors, as all P. P. E.'s, are not capable of providing total protection.

PERFORMANCE

CE type - Examination tests have assessed shock absorption to be in compliance with the reference standards EN1621-1/97 for protectors and EN 1621-2/03 for back protectors. These standards aim at the definition of the best possible protection level taking however into account also ergonomics and comfort.

INTENDED USE

The protectors are for use in snow sports.

PRELIMINARY CHECKS

Check that the protector is undamaged and in particular that the fixing straps are functional.

The protector complies with the scheduled safety characteristics only if the fixing straps are fastened properly.

If the protector (plastic shields and/or padding) is damaged in anyway, it must be replaced

Environmental temperatures for a safe use of the protectors should be less than -20°C , It is therefore recommended not to leave the protectors outdoor at low temperatures before use. The

manufacturer shall not be liable for any loss or damage due to impropeuse of the protectors.

INSTRUCTIONS FOR WEARING THE PROTECTOR

The protectors shall be donned so that they fully adhere to the specific protected body regions. If the protectors are incorporated into a garment, it is necessary that the garment be of the correct size so that the protectors fully fit over the protected body regions. In the case of back protectors they are donned on the back by fitting the arms below the elastic straps that are tightened by means of buckles. Then they are fastened to the waist by means of an elastic belt fitted with a "stick-down" velcro strap. The protectors shall be used in their full version with no part removed.

CLEANING

Do not soak the protectors in water. Do not use chemical products such as solvents, gasoline or abrasive materials.

Clean the surface with a damp sponge, without wetting the padding or elastic bands.

MAINTENANCE AND STORAGE

Store the protectors in a dry, ventilated room. Do not expose the protectors to temperatures above 40°C If they are held in place by velcro fastening devices, always check them before use removing dirt or whatever may impair efficiency. Protectors do not contain harmful material. Worn out protectors shall be wasted in litter containers.

All the information required : Marking.

The dimensions of the zone of protection, relative to the coverage provided by the whole product.

A specific warning that spinal injuries will not be prevented by the back protector.

No harmful substances are contained in the product.
